Proposed Amendment to the Constitution of the Friends of St Mary's Church, Stoke by Nayland

**Subject: Electronic Service of Notices and Website Publication** 

**Existing Clause:** 

Clause 12 Notices

Any notice may be served by the Secretary on any member either personally or by sending it through the post in a prepaid envelope addressed to such member at his or her last known address in the United Kingdom and any notice so sent shall be deemed to have been received within three working days of posting.

Proposed Amendment (to replace or supplement the existing clause):

Notices may be served by the Secretary on any member either personally, by sending it through the post in a prepaid envelope addressed to such member, or by electronic means, including email, provided that the member has supplied a valid email address and has not opted out of electronic communications. For members who have not provided a valid email address, notice may alternatively be given by publishing the notice on the Friends website, provided that the website is publicly accessible and the notice remains available for the full notice period.

Notices served electronically or published on the website shall be deemed to have been received on the day they are sent or posted, unless evidence to the contrary is provided.

**Subject: Electronic Service of Notices and Website Publication**

Clause 12 Notices
