Chairman's Report

During the year R.M. Wilks completed their skilled repairs to the south wall of St Mary's, the parapets and the chancel roof and the scaffolding was removed. This work was funded by the Restoration Fund set up by the Parochial Parish Council to finance the repairs and the Friends have so far donated £60,000 (in previous financial years) to the Fund.

For this financial year ending 31st March 2025, our income came to £7,549 which includes £900 from membership fees, £4,917 from donations, and the remaining amount from our investment holdings. At the end of our financial year, we had spent £5,179 of which £4,868 was on churchyard maintenance, compared with £2,000 in 2013. Our contractor has now started to charge VAT, and so sadly we agreed that, from April 2025, we will reduce the annual amount we pay to £3,000 plus VAT (£3,600 in total). This means that there is an annual shortfall of about £2,000 if we wish to keep the churchyard in good order.

At the end of the year our net asset balance was £36,146. The Friends have pledged a further £12,000 which will be called upon when the clerestory repair begins in late 2025. In addition, we have pledged £1,150 for urgent repairs to the organ which has been badly affected by water ingress from the roof. And there will be more to do including the church tower which is going to require substantial funding.

The scale and age of St. Mary's means that new needs are always arising, highlighting the ongoing importance of fundraising efforts and committed support from all who value our church's heritage. Every contribution, whether large or small, makes a tangible difference to the preservation of the church, whether focused on vital structural repairs or addressing more immediate concerns like the organ's condition or the upkeep of the churchyard.

As our core purpose is to raise funds for the ongoing care and repair of the church and churchyard, it's essential that our membership setup reflects the long-term financial needs of the charity and after much consideration we have made the following changes:

Reviewed our membership fees which will apply from 1st November 2025 and will be;

- £25 an individual, £40 for a family and all life members are encouraged to join the Friends on an annual membership basis
- Reduced our administrative costs, financial and time-related, by switching to digital communications

I am sure that you will understand and support our decision, and I would like to thank all of you who have already been in touch.

As usual I am very grateful to my co-trustees for their support and hard work.

Independent Examiner's Report to the Trustees of

Respective responsibilities of the trustees and examiner
